INFORMATION:

The Barangay Council of Barangay Libacao submitted its Tax Ordinance No. 2025-01 to this office for review last July 7, 2025. The same was referred to the Committee on Ways and Means, and Committee on Investment, Trade, Industry and Enterprises during the 2nd Regular Session of the Sanggunian.

FINDINGS:

The review has been done by the Committee, it was found out that all pertinent supporting documents have been submitted, such as Minutes of the Barangay Assembly dated June 5, 2025, that showed that the said Tax Ordinance has been tackled during the said assembly with proof of attendance.

The Ordinance was enacted for the purpose of generating income pursuant to Section 152 of the Local Government Code of 1991.
