RESOLUTION

GRANTING AUTHORITY CITY MAYOR TO TRANSFER FUNDS TO BARANGAY NABALI-AN IN THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) EACH AS CITY AID CHARGEABLE TO THE GENERAL FUND, SPECIAL PURPOSE APPROPRIATION, SUBSIDY TO LOCAL GOVERNMENT UNIT-AID TO BARANGAY, FY 2025 ANNUAL BUDGET

WHEREAS, Resolution No. 2025-04 dated January 2, 2025, adopted by the Barangay Council of Barangay Nabali-an, requested financial assistance from the City Government in the amount of Four hundred thousand pesos (P400,000.00) for its cultural activities;

WHEREAS, attached to the Request is the project proposal of the aforementioned barangay as well as the Certification from the City Accountant of the liquidation of the previous assistance granted;

WHEREAS, the amount of Four Hundred Pesos (P400,000.00) has been earmarked in the FY 2025 Annual Budget of the city as financial Aid chargeable to General fund, Special Purpose Appropriation, Subsidy to Local Government Unit;

NOW, THEREFORE, on motion of Hon. Janet T. Villafranca, seconded unanimously by all members present, it is;

RESOLVED, to grant authority to the City Mayor to transfer funds to Barangay Nabali-an in the amount of Four hundred thousand pesos (P400,000.00) as City Aid chargeable to the General Fund, Special Purpose Appropriation, Subsidy to Local Government Unit, Aid to Barangay, FY 2025 Annual Budget


