GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE EXECUTED BY AND BETWEEN THE TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES-VISAYAS (TUP-V) AND THE CITY OF HIMAMAYLAN, RELATIVE TO THE INTERNSHIP PROGRAM OF THE ABOVE-MENTIONED SCHOOL

WHEREAS, Student Internship Program (SIP) or On-the-Job (OJT) Training Program is designed to provide valuable work experiences for students who are just starting to explore career options, a requirement for all courses with practicum subject;

WHEREAS, it aims to promote and provide students with competitive skills and attitude for employment through practical application of learned theories and knowledge in an actual working environment;

WHEREAS, to ensure that the students will have a program-related and career-related work experience, they are placed in training areas that are aligned with their course;

WHEREAS, Technological University of the Philippines-Visayas (TUP-V) signifies its intention to have its student Internship Training in one of the offices in the City Government of Himamaylan for a maximum of Eight Hundred (800) working Hours as required;

WHEREAS, the City of Himamaylan commits to provide hands-on-trainings to Ms. Trisha N. Jabian, Bachelor of Engineering Technology major in Electrical Engineering Technology student at TUP-Visayas by giving her course-related work assignments and expose them to learning experience on actual operation and management;

WHEREAS, terms and conditions for this collaborative undertaking are stipulated in an agreement that will be executed by and between the parties;

NOW, THEREFORE, on motion of Teresita A. Gamposilao, seconded unanimously by all Members present, it is;

RESOLVED, to grant authority to the City Mayor to sign the Memorandum of Agreement (MOA) to be executed by and between the Technological University of the Philippines-Visayas (TUP-V) and the City of Himamaylan relative to the Internship Program of the above-mentioned school.
