GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE EXECUTED BY AND BETWEEN THE BINALBAGAN CATHOLIC COLLEGE (BCC) AND THE CITY OF HIMAMAYLAN RELATIVE TO THE ON-THE-JOB (OJT) TRAINING/INDUSTRY IMMERSION PROGRAM

WHEREAS, Student Internship Program (SIP) or On-the-Job (OJT) Training Program is designed to provide valuable work experiences for students who are just starting to explore career options, a requirement for all courses with practicum subject;

WHEREAS, it aims to promote and provide students with competitive skills and attitude for employment through practical application of learned theories and knowledge in an actual working environment:

WHEREAS, to ensure that the students will have a program-related and careerrelated work experience, they are placed in training areas that are aligned with their strand;

WHEREAS, Binalbagan Catholic College (BCC) instituted an IMMERSION program of Sixty (60) to Eighty (80) hours for office exposure and training as part of the curriculum in order to provide students with adequate experience in actual industry work operation and augment their formal education;

WHEREAS, the City of Himamaylan commits to provide hands-on-trainings to Binalbagan Catholic College Senior High School students under ABM, STEM, and HUMSS Strands by giving them strand-related work assignments and exposing them to learning experience in actual operation and management;

WHEREAS, terms and conditions for this collaborative undertaking are stipulated in an agreement that will be executed by and between the parties;
