RESOLUTION

ADOPTING BUREAU OF LOCAL GOVERNMENT FINANCE (BLGF) MEMORANDUM CIRCULAR NO. 020.2024 DATED DECEMBER 9, 2024, RELATIVE TO THE DEPARTMENT OF FINANCE ORDER NO. 074.2024, "SCHEDULE OF INCOME RECLASSIFICATION FOR THE FIRST GENERAL INCOME RECLASSIFICATION OF PROVINCE, CITIES, AND MUNICIPALITIES IN PURSUANCE OF REPUBLIC ACT NO. 11964, RECLASSIFYING THE CITY OF HIMAMAYLAN FROM A THIRD CLASS CITY TO A SECOND CLASS CITY

WHEREAS, Republic Act No. 11964 provides for the reclassification of provinces, cities and municipalities based on their annual income, which significantly impacts their share of national revenue allotment, as well as their authority, administrative capacity, and financial resources for development programs;

WHEREAS, Section 8 of the Implementing Rules and Regulations of Republic Act No. 11964 states that, "*Cities shall be classified into five (5) classes, according to their income ranges and based on the average annual regular income for three (3) fiscal years preceding the general income classification;*"

WHEREAS, Section 5(b) of the Department of Finance Order No. 074.2024 provides that "The average income classification for the 2nd class cities ranges One billion pesos (P1,000,000,000.00) or more, but not less than One billion three hundred million pesos (P1,300,000,000.00);

WHEREAS, the Bureau of Local Government Finance (BLGF) has issued Memorandum Circular No. 020-2024, dated December 9, 2024, endorsing the Department of Finance Order No. 074.2024, dated November 5, 2024, providing for the Schedule of the First General Income Classification of Provinces, Cities, and Municipalities in pursuance of R.A. No. 11964, otherwise known as the "Automatic Income Classification of Local Government Units (LGUs) Act;"

WHEREAS, this reclassification would entitle the City of Himamaylan to a higher income classification, thereby enhancing its fiscal capacity and enabling it to deliver better services to its constituents;

NOW, THEREFORE, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members present, it is;

RESOLVED, to adopt Bureau of Local Government Finance (BLGF) Memorandum Circular No. 020.2024, dated December 9, 2024, relative to the Department of Finance Order No. 074.2024, "Schedule of Income Reclassification for the First General Income Reclassification of province, cities, and municipalities in pursuance of Republic Act No. 11964, reclassifying the City of Himamaylan from a Third Class City to a Second Class City
