ADOPTING ANNEX "A-2" OF THE LOCAL BUDGET CIRCULAR NO. 160 DATED AUGUST 12, 2024, RELATIVE TO THE IMPLEMENTATION OF THE FIRST TRANCHE OF THE MODIFIED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNEL IN SECOND CLASS PROVINCES AND CITIES PURSUANT TO EXECUTIVE ORDER NO. 64 SERIES OF 2024 EFFECTIVE JANUARY 1, 2025

WHEREAS, the City of Himamaylan has been reclassified from a 3rd class city to a 2nd class city as per the Bureau of Local Government Finance (BLGF) Memorandum Circular No. 020.2024 dated December 9, 2024, in pursuance of the Department of Finance (DOF) Order No. 074.2024, entitled "Schedule of Income Reclassification for the First General Income Reclassification of Provinces, Cities, and Municipalities in Pursuance of Republic Act No. 11964, otherwise known as the "Automatic Income Classification of Local Government Units (LGUs) Act;"

WHEREAS, Local Budget Circular No. 160, dated August 12, 2024, provides the guidelines and specifics for the implementation of the salary adjustments, including Annex "A-2" as First Tranche Monthly Salary Schedule for Local Government Personnel in Second Class Provinces and Cities;

WHEREAS, Section 4 of the EO No. 64 stipulates that the updated Salary Schedule for civilian government personnel may likewise be granted to personnel of local government units (LGUs), subject to (a) authorization from the respective sanggunian as provided under Section 458(a) of Republic Act No. 7160 or the "Local Government Code of 1991," and (b) compliance with the Personnel Services (PS) limitation in the LGU budget under Section 325 of RA No. 7160;

WHEREAS, it is imperative for the local government to adopt and implement the provisions of Local Budget Circular No. 160 to ensure compliance with the prescribed salary adjustments and to support the welfare of local government personnel;

NOW, THEREFORE, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members present, it is;

RESOLVED, to adopt Annex "A-2" of the Local Budget Circular No. 160 dated August 12, 2024 relative to the implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel in Second Class Provinces and Cities pursuant to Executive Order No. 64 series of 2024 effective January 1, 2025
