RESOLUTION

GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE EXECUTED BY AND BETWEEN THE CITY OF HIMAMAYLAN AND THE PARTICIPATING BARANGAYS RELATIVE TO THE TRANSFER OF FUNDS IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) AS FINANCIAL ASSISTANCE TO THE HIMAYA DANCE PRESENTATION 2025 AND HIMAYA QUEEN 2025 AS PART OF THE CULTURAL ACTIVITIES AND TOURISM PROMOTION OF THE CITY

WHEREAS, the City of Himamaylan will be holding a HIMAYA Dance Presentation 2025 and HIMAYA Queen 2025 as part of its Cultural Activities and Tourism Promotion during the celebration of HIMAYA Festival;

WHEREAS, HIMAYA Dance Presentation 2025 and HIMAYA Queen 2025 are part of the highlights of the said celebration, as it involve the participation of the barangay performers, showing their skills by way of dance interpretation and depicting the culture of Himamaylanon;

WHEREAS, the barangay is invited by the City to participate in the HIMAYA Dance Presentation 2025 and HIMAYA Queen 2025, which aims to foster unity, promotes tourism industry and general community's involvement in a one grant celebration of thanksgiving;

WHEREAS, the City will extend financial assistance to the participating barangay to the HIMAYA Dance Presentation in the amount of One Hundred Twenty thousand pesos (P120,000.00) which will be used for the participants costumes and other related expenses for the said event and Thirty Thousand Pesos (P30,000.00) intended for the HIMAYA Queen 2025;

NOW, THEREFORE, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members, it is;

RESOLVED, to grant authority to the City Mayor to sign the Memorandum of Agreement (MOA) to be executed by and between the City of Himamaylan and the participating barangays relative to the transfer of funds in the amount of One Hundred Fifty Thousand Pesos (P150,000.00) as financial assistance to the HIMAYA Dance Presentation 2025 and HIMAYA Queen 2025 as part of the cultural activities and tourism promotion of the city
