RESOLUTION

GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE DEED OF USUFRUCT TO BE EXECUTED BY AND BETWEEN THE CITY OF HIMAMAYLAN AND THE OFFICE OF THE CIVIL DEFENSE, NEGROS ISLAND REGION, RELATIVE TO THE 1,191 SQUARE METERS PORTION OF LAND FOR THE CONSTRUCTION OF SATELLITE OFFICE AND OTHER FACILITIES

WHEREAS, the Office of the Civil Defense (OCD), Negros Island Region which was created pursuant to Republic Act No. 12000 needs to establish a satellite office and other facilities in Negros Island specifically in Southern Negros;

WHEREAS, the City of Himamaylan recognizes the urgent need of the Office of the Civil Defense to construct its satellite office to carry out its functions, and offers an area of One Thousand One Hundred Ninety One (1,191) square meters, Lot A, portion of parcel of land with Transfer Certificate of Title No. 091-2021001910, containing an area of Eight Thousand Five Hundred Seventy One (8,571) square meters situated at Barangay Talaban, Himamaylan City, for the aforesaid purpose;

WHEREAS, the term of the usufruct shall be for Twenty-Five (25) years, renewable at the discretion of the City of Himamaylan, being the lawful and registered owner of the parcel of land;

WHEREAS, the execution of a Deed of Usufruct will formalize the terms and conditions stipulated therein;

NOW, THEREFORE, on motion of Hon. Teresita A. Gamposilao, seconded unanimously by all Members present, it is;

RESOLVED, to grant authority to the City Mayor to sign the Deed of Usufruct to be executed by and between the City of Himamaylan and the Office of the Civil Defense, Negros Island Region, relative to the 1,191 square meters portion of land for the construction of satellite office and other facilities

RESOLVED FINALLY, to furnish copy of this resolution to all concerned for their information and appropriate action
