RESOLUTION

GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE EXECUTED BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF HIMAMAYLAN AND THE HEARTICULATE PSYCHOLOGICAL CENTER, RELATIVE TO THE CONDUCT OF PSYCHOTHERAPY AND COUNSELING, PSYCHOLOGICAL ASSESSMENT, AND OTHER RELATED SERVICES

WHEREAS, mental illness has become the third most common disability in the Philippines, where six million Filipinos live with depression and anxiety and is considered to have the third highest rate of mental disorders in the Western Pacific;

WHEREAS, the mental health crisis in the country requires a united effort from all sectors of society, including local and national governments, the private sector and the workplace, health care providers, communities, schools, and individuals, to help promote Filipinos' mental wellness;

WHEREAS, in response to the issues of mental health, the City Government of Himamaylan intends to coordinate and make ties with the Hearticulate Psychological Center to avail its services through the conduct of psychotheraphy and counseling, psychological assessment, and other related services that focus on the mental health and well-being of its residents;

WHEREAS, as stipulated in the Memorandum of Agreement (MOA), the city agrees to pay a retainer's fee of Forty thousand pesos (P40,000.00) per month to cover twelve (12) sessions of psychotheraphy/counseling sessions and one (1) psychological assessment or two (2) psychological evaluations for client victims of all forms of gender-based violence and for Children in Conflict with the Law (CICL);

WHEREAS, this Memorandum of Agreement (MOA) clearly stipulates the terms and conditions to be executed between the parties;

NOW, THEREFORE, on motion of Hon. Teresita A. Gamposilao, unanimously seconded by all members present, it is;

RESOLVED, to grant authority to the City Mayor to enter into and sign the Memorandum of Agreement (MOA) to be executed by and between the Local Government Unit of Himamaylan and the Hearticulate Psychological Center, relative to the conduct of psychotherapy and counseling, psychological assessment, and other related services

RESOLVED FINALLY, to furnish copy of this resolution to all concerned for their information and appropriate action.
