RESOLUTION

APPROVING BARANGAY TAX ORDINANCE NO. 2024-01, AN ORDINANCE AMENDING THE 2005 REVENUE CODE OF BARANGAY II-POBLACION, CITY OF HIMAMAYLAN

WHEREAS, barangays can generate its own sources of revenue subject to the provisions set forth in Section 152 of the 1991 Local Government Code;

WHEREAS, the Barangay Council of Barangay II-Poblacion enacted its Revenue Code to generate local funds for the programs and projects of the barangay that will redound to the best interest of its constituents;

WHEREAS, Section 458(a)(1)(i) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to review all ordinances approved by the Sangguniang Barangay and to determine whether the same are within the scope of the prescribed powers of the sangguniang barangay;

WHEREAS, the same has been referred for review to the Joint Committee on Ways and Means and Committee on Investment, Trade, Industry, and Economic Enterprises;

WHEREAS, as per review and evaluation of the aforementioned Committees, the said revenue measure has substantially complied with the requirements set forth in the Local Government Code;

WHEREAS, the said revenue measure has also been found to be within the power of the Sangguniang Barangay concerned as provided under the Local Government Code of 1991;

NOW THEREFORE, on motion of Hon. Kerwin L. Tongson, seconded unanimously by all Members present, it is;

RESOLVED, to approve Barangay Tax Ordinance No. 2024-01, An Ordinance Amending the 2005 Revenue Code of Barangay II-Poblacion, City of Himamaylan

RESOLVED FINALLY, to furnish copy of this resolution to all concerned for their information and appropriate action


