**WHEREAS**, presented for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the FY 2025 Annual Budget of **BARANGAY MAMBAGATON** involving an appropriation of **EIGHT MILLION TWO HUNDRED TWENTY THOUSAND NINE HUNDRED FIFTY SEVEN PESOS ONLY (P8,220,957.00)**, enacted by the Sangguniang Barangay under Appropriation Ordinance No. 2024-04 dated October 20, 2024;

**WHEREAS**, the Local Finance Committee pre-reviewed the above mentioned budget and endorsed the same to the Sangguniang Panlungsod for appropriate action;

**WHEREAS**, a budget hearing has been conducted in the presence of the Honorable Presiding Officer Hon. Justin Dominic S. Gatuslao and the Members of the Committee on Appropriations, together with the Barangay Council of Barangay Mambagaton, in their respective barangay on February 19, 2025 at 10 o'clock in the morning;

**WHEREAS**, the Committee on Appropriations where the same has been referred to, found said budget to have complied with the requirements of Section 333 of the 1991 Local Government Code;

**NOW, THEREFORE**, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members present, it is;

**RESOLVED**, to declare operative in its entirety the FY 2025 Annual Budget of Barangay Talaban, this city, subject to accounting and auditing rules and other issuances

**RESOLVED FINALLY**, to furnish copy of this resolution to all concerned for their information and appropriate action



