WHEREAS, presented for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the FY 2025 Annual Budget of BARANGAY MAMBAGATON involving an appropriation of EIGHT MILLION TWO HUNDRED TWENTY THOUSAND NINE HUNDRED FIFTY SEVEN PESOS ONLY (P8,220,957.00), enacted by the Sangguniang Barangay under Appropriation Ordinance No. 2024-04 dated October 20, 2024;

WHEREAS, the Local Finance Committee pre-reviewed the above mentioned budget and endorsed the same to the Sangguniang Panlungsod for appropriate action;
