WHEREAS, the Office of the Presidential Adviser on Peace Process and Reconciliation for Unity (OPAPPRU) is mandated to oversee the comprehensive peace agenda of the government and monitor the effectiveness of reforms that address causes of armed conflict;

WHEREAS, the OPAPPRU has engaged the DSWD to improve access of conflict-affected and vulnerable areas to basic social services and accountable governance in identified Payapa and Masaganang Pamayanan (PAMANA) zones;

WHEREAS, PAMANA - Peace and Development is an intervention that works through a localized and participatory process in marginalized and vulnerable communities guided by Memorandum Circular No. 09 series of 2023;

WHEREAS, the Local Government Unit of Himamaylan recognizes the importance of engaging communities affected by conflict in meaningful development process where there is full recognition of their capacity to strengthen their economic, social, political systems and institutions, recovery, and rehabilitation:

WHEREAS, the Memorandum of Agreement (MOA) and the Specific Implementation Agreement (SIA) outlines the roles, responsibilities, and commitments of the Department of Social Welfare and Development (DWSD) and the Local Government of the City of Himamaylan;

WHEREAS, it is necessary to grant authority to the City Mayor to sign the MOA and the SIA on behalf of the City Government to ensure the successful implementation of the project;

NOW THEREFORE, on motion of Hon. Teresita A. Gamposilao, seconded unanimously by all Members present, it is;

RESOLVED, to grant authority to the City Mayor to sign the Memorandum Of Agreement (MOA) And The Specific Implementation Arrangement (SIA) for the PAMANA - Peace And Development Program, to be executed by and between the Department Of Social Welfare And Development (DSWD) and the Local Government Unit of the City of Himamaylan, relative to the implementation of recovery measures and the implementation of a Social Protection Program for conflict-affected areas in the City
