GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) AND THE LOCAL GOVERNMENT UNIT OF HIMAMAYLAN, RELATIVE TO THE IMPLEMENTATION OF THE ASSISTANCE TO INDIVIDUALS AND FAMILIES IN CRISIS SITUATION (AICS) PROGRAM

WHEREAS, the Department of Social Welfare and Development (DSWD) pursuant to Executive Order No. 221, s. 2003 and Executive No. 137, s. 2021, implements crisis intervention, through the Assistance to Individuals and Families in Crisis Situation (AICS) Program;

**WHEREAS**, the Local Government Unit of Himamaylan is mandated by law to discharge basic services, including social welfare services to its constituents;

**WHEREAS**, the DSWD and the LGU are partners in the implementation of social services for the poor, vulnerable, and marginalized sectors;

WHEREAS, there is a need for a Memorandum of Agreement (MOA) to capture the terms of the cooperation mechanism to ensure effective and efficient delivery of AICS to qualified beneficiaries in accordance with MC No. 16, s. 2022 including supplementary issuances thereto, and other pertinent accounting, budgeting and auditing laws, rules and regulations;

WHEREAS, the Memorandum of Agreement (MOA) outlines the roles, responsibilities, and commitments of the Department of Social Welfare and Development (DWSD) and the Local Government Unit of Himamaylan;

WHEREAS, the Memorandum of Agreement will be executed by and between the Local Government Unit of Himamaylan represented by the City Mayor, Hon. Rogelio Raymund I. Tongson, Jr. and the Department of Social Welfare and Development (DSWD) represented by Regional Director, Arwin O. Razo;

**NOW THEREFORE**, on motion of Hon. Teresita A. Gamposilao, seconded unanimously by all Members present, it is;

**RESOLVED,** to grant authority to the City Mayor to sign the Memorandum Of Agreement (MOA) by and between the Department Of Social Welfare And Development (DSWD) and the Local Government Unit of Himamaylan, relative to the implementation of the Assistance to Individuals and Families In Crisis Situation (AICS) Program
