**RESOLUTION**

**DECLARING OPERATIVE IN ITS ENTIRETY THE FY 2024 SUPPLEMENTAL BUDGET  
OF THE SANGGUNIANG KABATAAN OF BARANGAY II-POBLACION, THIS CITY**

**WHEREAS**, submitted for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the Supplemental Budget No. 1 and 2 FY 2024 of the **Sangguniang Kabataan of Barangay II-Poblacion**, to wit:

1. Supplemental Budget No. 1 with an appropriation of **Seven Hundred Thousand Pesos and 0/100 (P700,000.00)**, adopted on April 12, 2024 per Resolution No. 2024-009; and
2. Supplemental Budget No. 2 with an appropriation of **One Million One Hundred Ninety One Thousand Five Hundred Seventy Four Pesos and 0/100 (P1,191,574.00)**, adopted on July 19, 2024 per Resolution No. 2024-0012.

**WHEREAS**, the Local Finance Committee received the aforementioned Resolutions on February 6, 2025, pre-reviewed the same supplemental budgets, and endorsed the same to the Sangguniang Panlungsod for appropriate action;

**WHEREAS**, the Local Finance Committee noted that the same budgets are contrary to JMC No. 2019-01 on the Budget Authorization Section 3.3.3.4 of DBM-DILG NYC Series of 2019, for being submitted beyond the reglementary period;

**WHEREAS**, the Committee on Appropriations held a Committee Meeting with the City Budget Officer to tackle and ask for clarifications with regard to the said matter;

**WHEREAS**, it is found that despite being submitted beyond the reglementary period, the same budgets are in compliance in substance and form with the requirement and other relevant provisions of the DBM-DILG-NYC, JMC No. 2019-01 and Republic Act No. 10742;

**WHEREAS**, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Member present, it is;

**RESOLVED**, to declare operative in its entirety the FY 2024 Supplemental Budgets No. 1 and 2 of the **Sangguniang Kabataan of Barangay II-Poblacion**, this City, subject to accounting and auditing rules, and other issuances

**RESOLVED FURTHER**, to remind all Sangguniang Kabataan Councils to submit their respective Annual and Supplemental Budgets within the specified period under law and that the repetition of the same instance will be scrutinized more stringently by this Honorable Body;

**RESOLVED FINALLY**, to furnish copy of this resolution to all concerned for their information and appropriate action
