RESOLUTION

GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE EXECUTED BY AND BETWEEN THE PHILIPPINE STATISTICS AUTHORITY (PSA) AND THE CITY OF HIMAMAYLAN RELATIVE TO THE IMPLEMENTATION OF THE BATCH REQUEST SYSTEM (BREQS)

WHEREAS, the Philippine Statistics Authority (PSA), through the Civil Registry System Information Technology Project (CRS-ITP), has established On-line Civil Registry System (CRS) Outlets in various locations in the Philippines to service as service points for the decentralized servicing of requests for civil registry documents (CRDs);

WHEREAS, acknowledging the need to extend the availability of these service points to the public, PSA has developed the BATCH REQUEST SYSTEM (BREQS) - to be

known as "BREQS", a system which provides an off-line method of encoding request for CRDs and submission thereof to an on-line CRS Outlets of the PSA;

WHEREAS, the City of Himamaylan, through the Office of the City Civil Registrar, as part of its mandate, receives request for issuance of CRDs registers in the City;

WHEREAS, the City of Himamaylan is interested in the BREQS System to provide a more extensive service to the constituents relative to vital events (i.e., Birth, Marriage, and Death) and documents registered in the city including those that may have been registered in other localities;

WHEREAS, the Memorandum of Agreement (MOA) outlines the roles, responsibilities, and commitments of the PSA and the City of Himamaylan;

WHEREAS, it is necessary to grant authority to the City Mayor to sign the MOA on behalf of the City to ensure the successful implementation of the project;

NOW THEREFORE, on motion of Hon. Teresita A. Gamposilao, seconded unanimously by all Members present; it is

RESOLVED, to grant authority to the City Mayor to sign the Memorandum of Agreement by and between the Philippine Statistics Office and the City of Himamaylan relative to the implementation of the Batch Request System (BREQS)

RESOLVED FURTHERMORE, that a copy of the signed Memorandum of Agreement be furnished to this office;

RESOLVED FINALLY, to furnish copy of this resolution to all concerned for their information and appropriate action
