APPOINTMENTS AND OTHER HUMAN RESOURCES ACTIONS (ORA-OHRA)**

WHEREAS, Section 88, Rule IX of the 2017 Omnibus Rules on Appointment and Other Human Resource Actions, prescribed the composition of the Human Resource Merit Promotion and Selection Board (HRMPSB);

WHEREAS, Section 84 of the same Rules provides that, "each agency may constitute two (2) Human Resource Merit Promotion and Selection Board (HRMPSB) - one for the First and Second Level Positions and other for Second Level Executive/Managerial Positions;

WHEREAS, for Local Government Units, the HRMPSB shall be chaired by the local chief executive, or his/her authorized representative, and its members shall be determined by resolution of the Sanggunian concerned;



