**RESOLUTION**

**GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) AND THE LOCAL GOVERNMENT UNIT OF HIMAMAYLAN RELATIVE TO THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM**

**WHEREAS**, the Department of Social Welfare and Development (DSWD) in its mandate to provide social welfare and development programs, particularly through technical assistance and resource augmentation, has been providing community-based nutrition programs and services such as Food for School and Healthy Start Feeding Program in child development centers at the local government units;

**WHEREAS**, Supplementary Feeding is the provision of food in addition to the regular meals to target children aged 2-5 years old enrolled in the Child Development Center (CDCs) and Supervised Neighborhood Play (SNPs) as part of the DSWD's contribution to the early childhood care and development (ECCD) program of the government;

**WHEREAS**, under Section 4(a) of RA No. 11037, the DSWD, in coordination with the LGUs concerned, has been tasked to implement the aforementioned program in day care centers or in any facility used for such purpose;

**WHEREAS**, a Memorandum of Agreement (MOA) defining the roles and responsibilities of the parties in relation to implementation of this program in the city will be executed by and between the Department of Social Welfare and Development (DSWD) and the Local Government Unit of Himamaylan;

**NOW THEREFORE**, on motion of Hon. Teresita A. Gamposilao, seconded unanimously by all Members present; it is

**RESOLVED**, to grant authority to the City Mayor to sign the Memorandum of Agreement (MOA) to be executed by and between the Department of Social Welfare and Development (DSWD) and the Local Government Unit of Himamaylan relative to the implementation of the Supplementary Feeding Program

**RESOLVED FURTHERMORE**, that a copy of the signed Memorandum of Agreement be furnished to this office;

**RESOLVED FINALLY**, to furnish copy of this resolution to all concerned for their information and appropriate action




