**WHEREAS**, presented for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the FY 2025 Annual Budget of **BARANGAY SU-AY** involving an appropriation of **ELEVEN MILLION SEVEN HUNDRED THIRTY THOUSAND THIRTEEN PESOS AND 0/100 ONLY (P11,730,013.00)**, enacted by the Sangguniang Barangay under Appropriation Ordinance No. 2024-02 dated December 20, 2024;

**WHEREAS**, the Local Finance Committee pre-reviewed the above mentioned budget and endorsed the same to the Sangguniang Panlungsod for appropriate action;

**WHEREAS**, a budget hearing has been conducted in the presence of the Honorable Members of the 9th Sangguniang Panlungsod together with the Barangay Council of Barangay Su-ay, in their respective barangay on April 2, 2025 at 10 o'clock in the morning;

**WHEREAS**, the Committee on Appropriations where the same has been referred to, found said budget to have complied with the requirements of Section 333 of the 1991 Local Government Code;

**NOW, THEREFORE**, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members present, it is;

**RESOLVED**, to declare operative in its entirety the **FY 2025 Annual Budget of Barangay Su-ay**, this city, subject to accounting and auditing rules and other issuances
