WHEREAS, presented for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the FY 2025 Annual Budget of BARANGAY SARA-ET involving an appropriation of SIX MILLION SEVEN HUNDRED FORTY NINE THOUSAND THREE HUNDRED THIRTY SIX PESOS AND 0/100 ONLY (P6,749,336.00), enacted by the Sangguniang Barangay under Appropriation Ordinance No. 2024-04 dated December 26, 2024;
