WHEREAS, presented for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the FY 2025 Annual Budget of **BARANGAY SARA-ET** involving an appropriation of **SIX MILLION SEVEN HUNDRED FORTY NINE THOUSAND THREE HUNDRED THIRTY SIX PESOS AND 0/100 ONLY (P6,749,336.00)**, enacted by the Sangguniang Barangay under Appropriation Ordinance No. 2024-04 dated December 26, 2024;

WHEREAS, the Local Finance Committee pre-reviewed the above mentioned budget and endorsed the same to the Sangguniang Panlungsod for appropriate action;

WHEREAS, a budget hearing has been conducted in the presence of the Honorable Members of the 9th Sangguniang Panlungsod together with the Barangay Council of Barangay Sara-et, in their respective barangay on April 9, 2025 at 10 o'clock in the morning;

WHEREAS, the Committee on Appropriations where the same has been referred to, found said budget to have complied with the requirements of Section 333 of the 1991 Local Government Code;

NOW, THEREFORE, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members present, it is;


