DECLARING OPERATIVE IN ITS ENTIRETY FY 2025 ANNUAL BUDGET OF BARANGAY BUENAVISTA, THIS CITY

WHEREAS, presented for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the FY 2025 Annual Budget of BARANGAY BUENAVISTA involving an appropriation of TEN MILLION EIGHT HUNDRED NINETY THREE THOUSAND FORTY SEVEN PESOS AND 0/100 ONLY (P10,893,047.00), enacted by the Sangguniang Barangay under Appropriation Ordinance No. 2024-002 dated December 20, 2024;

WHEREAS, the Local Finance Committee pre-reviewed the above mentioned budget and endorsed the same to the Sangguniang Panlungsod for appropriate action;

WHEREAS, a budget hearing has been conducted in the presence of the Honorable Members of the 9th Sangguniang Panlungsod together with the Barangay Council of Barangay Buenavista, in their respective barangay on April 10, 2025 at 1 o'clock in the afternoon:

WHEREAS, the Committee on Appropriations where the same has been referred to, found said budget to have complied with the requirements of Section 333 of the 1991 Local Government Code;

NOW, THEREFORE, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members present, it is;

RESOLVED, to declare operative in its entirety the FY 2025 Annual Budget of Barangay Buenavista, this city, subject to accounting and auditing rules and other issuances
