RESOLUTION

GRANTING AUTHORITY TO THE CITY MAYOR TO SAID THE MEMORANDUM OF AGREEMENT BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE VI AND THE LOCAL GOVERNMENT UNIT OF HIMAMAYLAN CITY RELATIVE TO THE IMPLEMENTATION OF THE WALANG GUTOM PROGRAM 2027: FOOD STAMP PROGRAM

WHEREAS, by virtue of Presidential Executive Order No. 44, series of 2023, the “Walang Gutom 2027: Food Stamp Program” of the Department of Social Welfare and Development (DSWD) was declared as a Flagship Program of the National Government, with the DSWD as the lead implementing agency responsible for its management and execution;

WHEREAS, the said program aims to decrease the incidence of involuntary hunger experienced by low-income families through the provision of Electronic Benefit Transfer (EBT) Cards, which can be used to purchase select food commodities at eligible partner stores and merchants;

WHEREAS, the DSWD Central Office has delegated the DSWD Field Office VI to coordinate with the Local Government of Himamaylan City for the implementation of the said program;

WHEREAS, a Memorandum of Agreement (MOA) defining the roles and responsibilities of the parties in relation to implementation of this program in the city will be executed by and between the Department of Social Welfare and Development FO-VI and the Local Government Unit of Himamaylan;

NOW THEREFORE, on motion of Hon. Teresita A. Gamposilao, seconded unanimously by all Members present; it is

RESOLVED, to grant authority to the City Mayor to sign the Memorandum of Agreement (MOA) to be executed by and between the Department of Social Welfare and Development Field Office - VI and the Local Government Unit of Himamaylan relative to the implementation of the Walang Gutom 2027: Food Stamp Program

RESOLVED FURTHERMORE, that a copy of the signed Memorandum of Agreement be furnished to this office;

RESOLVED FINALLY, to furnish copy of this resolution to all concerned for their information and appropriate action




