WHEREAS, presented for review and appropriate action pursuant to Section 57 of the 1991 Local Government Code is the FY 2025 Annual Budget of **BARANGAY CARADIO-AN** involving an appropriation of **THIRTEEN MILLION FOUR HUNDRED NINETY THOUSAND FOUR HUNDRED SIXTY ONE PESOS AND 0/100 ONLY (P13,490,461.00)**, enacted by the Sangguniang Barangay under Appropriation Ordinance No. 2024-003 dated December 16, 2024;

WHEREAS, the Local Finance Committee pre-reviewed the above mentioned budget and endorsed the same to the Sangguniang Panlungsod for appropriate action;

WHEREAS, a budget hearing has been conducted in the presence of the Honorable Members of the 9th Sangguniang Panlungsod together with the Barangay Council of Barangay Caradio-an, in their respective barangay on April 23, 2025 at 10 o'clock in the morning;

WHEREAS, the Committee on Appropriations where the same has been referred to, found said budget to have complied with the requirements of Section 333 of the 1991 Local Government Code;

NOW, THEREFORE, on motion of Hon. Janet T. Villafranca, seconded unanimously by all Members present, it is;

RESOLVED, to declare operative in its entirety the **FY 2025 Annual Budget of Barangay Caradio-an**, this city, subject to accounting and auditing rules and other issuances



