WHEREAS, the Philippine Coast Guard (PCG) is mandated to enforce regulations in accordance with all relevant maritime international conventions, treaties, or instruments, and national laws, as well as conduct maritime law enforcement, and implement laws on fisheries, immigration, tariff, customs, forestry, firearms, human trafficking, and other crimes under the Philippines laws within its maritime jurisdiction;

WHEREAS, the Coast Guard District Southern Visayas of the PCG is in need of a building to be utilized as its Sub-Station, stationed in Himamaylan City;

WHEREAS, the City of Himamaylan, as the registered and absolute owner of a parcel of land known as Lot 637-b-4 with a 37.16 square meter building in Barangay Aguisan, is willing to offer the same to PCG under a Deed of Usufruct;

WHEREAS, the term of the usufruct shall be for Twenty-Five (25) years, renewable at the discretion of the City of Himamaylan, being the lawful and registered owner of the aforementioned property;

WHEREAS, the execution of a Deed of Usufruct will formalize the terms and conditions stipulated therein.
