WHEREAS, Article 410 of the Implementing Rules and Regulations of the 1991 Local Government Code provides, "The local development council shall submit to the Local Finance Committee (LCF) a copy of the local development plan and Annual Investment Program (AIP) prepared and approved during the fiscal year before the calendar for budget preparation in accordance with applicable laws, specifying therein projects proposed for inclusion in the local government budget, as well as, in the budget of the National Government Agencies or Government Owned and Controlled Corporations;"

WHEREAS, the adoption of the AIP is essentials as it serves as the basis for the funding of several programs, projects, and activities of the City which shall be supported and implemented through the enactment of a corresponding Appropriation Ordinance for the ensuing year;

WHEREAS, the total resource requirement for the budget year as per detailed annual allocation of the PPAs, and the regular operation budget items is Eighteen Billion Nine Hundred Two Million One Hundred Ninety Thousand Pesos (18,902,190,000.00) with the following sectoral allocations:
