#### RESOLUTION

APPROVING BARANGAY TAX ORDINANCE NO. 2025-01, AN ORDINANCE ADOPTING THE REVENUE CODE OF BARANGAY LIBACAO, CITY OF HIMAMAYLAN

**WHEREAS,** barangays can generate its own sources of revenue subject to the provisions set forth in Sec. 152 of the 1991 Local Government Code;

WHEREAS, the Barangay Council of Barangay Libacao enacted its Revenue Code to generate local funds for the programs and projects of the barangay that will redound to the best interest of their constituents;

WHEREAS, Section 458(a)(1)(i) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to review all ordinances approved by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian;

WHEREAS, the review and the evaluation process confirmed that the enactment of the said ordinance is within the power of the Sangguniang Barangay concerned as provided under R.A. 7160 otherwise known as the Local Government Code of 1991, particularly Section 152 and Section 187 hereof;

**NOW, THEREFORE,** on motion of Hon. Pablo M. Libo-on, seconded unanimously by all Members present, it is;

**RESOLVED,** to approve Barangay Tax Ordinance No. 2025-01, an Ordinance Adopting the Revenue Code of Barangay Libacao, Himamaylan City;

**RESOLVED FINALLY,** to furnish a copy of this resolution to all concerned for their information and appropriate action.
