**RESOLUTION**

**REQUESTING THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL FOR ASSISTANCE IN DECLOGGING AND DESILTING THE VARIOUS SILTED RIVERS OF HIMAMAYLAN CITY WHICH CAUSED FLOODING DURING THE ONSLAUGHT OF TROPICAL DEPRESSION CRISING LAS JULY 17-18, 2025**

**WHEREAS**, the City of Himamaylan experienced heavy flooding brought about by the onslaught of Tropical Depression Crising on July 17 to 18, 2025, resulting in damage to properties, disruption of livelihoods, and displacement of residents in several areas and barangays;

**WHEREAS**, initial assessments revealed that the severe flooding was aggravated by the heavily silted and clogged rivers traversing the city, which hindered the natural flow of water and contributed to the rapid rise of floodwaters;

**WHEREAS**, there is an urgent need to declog and desilt these rivers in order to prevent further flooding, protect lives and properties, and ensure the safety and well-being of the residents of Himamaylan City;

**WHEREAS**, the City Government of Himamaylan recognizes the technical capability and resources of the Provincial Government of Negros Occidental in undertaking large-scale river declogging and desilting operations;

**WHEREAS**, the assistance of the Provincial Government is hereby earnestly sought to support the city's recovery and disaster mitigation efforts;

**NOW, THEREFORE**, on motion of Hon. Esther Marie B. Tongson, seconded unanimously by all Members present, it is;

**RESOLVED**, to request the Provincial Government of Negros Occidental for assistance in declogging and desilting the various silted rivers of Himamaylan City which caused flooding during the onslaught of Tropical Depression Crisining on July 17-18, 2025;

**RESOLVED FINALLY**, to furnish copy of this resolution to all concerned for their information and appropriate action

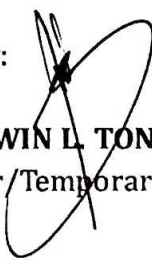
