WHEREAS, Student Internship Program (SIP) of On-the-Job (OJT) Training Program is designed to provide valuable work experiences for students who are just starting to explore career options, a requirement for all courses with practicum subjects;

WHEREAS, it aims to promote and provide students with competitive skills and attitude for employment through practical application of learned theories and knowledge in an actual working environment;

WHEREAS, to ensure that the students will have a program-related and career-related work experience, they are placed in training areas that are aligned with their course;

WHEREAS, Central Philippines State University (CPSU) signifies its intention to have its Student Internship Training at various offices in the City Government of Himamaylan for a maximum of Two Hundred Forty (240) working Hours as required;

WHEREAS, the City of Himamaylan commits to provide hands-on-trainings to UNO-R students by giving them course-related work assignments and expose them to learning experience on actual operation and management;

RESOLVED FURTHERMORE, that a copy of the Memorandum of agreement be furnished to this Office for reference;

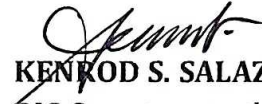
