WHEREAS, Section 35(b) of the Local Government Code of 1991 provides that local government units may establish linkages with local or international organizations, whether public or private, for the purpose of pursuing delivery of basic services, priority programs, and projects;

WHEREAS, sister-city or town-twinning is the highest form of inter-LGU partnership in the country or abroad, which enables partner communities or local authorities to implement mutually-beneficial activities;

WHEREAS, the concept of sisterhood or town-twinning aims to foster mutual understanding, cooperation, and exchange of best practices in areas such as governance, culture, education, trade and commerce, tourism, environmental protection, and other areas of mutual interest;

WHEREAS, the City of Cebu is one of the highly urbanized cities in the Philippines, with a rich cultural heritage, vibrant economy, and dynamic local governance, making it a valuable partner in a sisterhood or twinning relationship;

WHEREAS, the proposed Sister-City or Twinning Agreement between the City of Himamaylan and the City of Cebu is expected to strengthen ties and collaboration that will be beneficial to both cities and their constituents;
