### RESOLUTION

AUTHORIZING CYCHE G. HISONA, Ph.D., CITY GOVERNMENT DEPARTMENT HEAD I, TO SIGN AND ACT ACCORDINGLY IN BEHALF OF THE CITY MAYOR THE DISBURSEMENT VOUCHERS, CHECKS, OBLIGATION REQUEST AND SUPPORTING DOCUMENTS REGARDLESS OF THE AMOUNT FOR SPECIFIC TRANSACTIONS

WHEREAS, Section 455 of the Republic Act No. 7160, otherwise known as the Local Government code of 1991. Explicitly provides the powers, function and duties of the City Mayor as the local chief executive of the city government, and is further mandated to promptly exercise and perform the same and ensure as efficient, effective and economical governance, to protect and carry-out the interest, and promote the general welfare of the city and its people;

WHEREAS, considering the magnitude of functions and duties of the City Mayor and the need to provide prompt and exigent actions to all matters and businesses required from him, there is a need to delegate certain duties and authorities of the City Mayor to some of his Executive Officers;

WHEREAS, the Local Chief Executive has authorized Cyche G. Hisona, Ph.D., City Government Department Head I to sign and approve Disbursement Vouchers, Checks, Obligation Request and supporting documents regardless of the amount, only for the payment of the following:

- Term loan amortizations with LandBank of the Philippines (LBP) and Development Bank of the Philippines (DBP);
- GSIS Premiums and Insurance and other payments;
- PAG-IBIG;
- GSIS;
- PhilHealth;
- BIR employee compensation
- BIR-taxes from suppliers;
- BIR Documentary Stamp;
- KCAT Internet;
- Globe Internet;
- Innove Internet;
- PLDT Internet;
- Smoke emission;
- LTO
- NOCECO; and
- Prime Water

**WHEREAS**, this August Body finds this request deemed necessary so as not to delay the aforementioned transactions;
