RESOLUTION

GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF HIMAMAYLAN RELATIVE TO THE ESTABLISHMENT OF PARTNERSHIP AND REFERRAL SYSTEM BETWEEN THE CITY HEALTH OFFICE AND THE GOVERNOR VALERIANO M. GATUSLAO MEMORIAL HOSPITAL

WHEREAS, the City Government of Himamaylan City and the Provincial Government of Negros Occidental aim to strengthen collaboration in delivery efficient and quality health care services to to its constituents;

WHEREAS, the Provincial Government of Negros Occidental through the Governor Valeriano M. Gatuslao Memorial Hospital (GVMGMH) and the City Government of Himamaylan through the City Health Office have agreed to establish a formal partnership and referral system to meet the Department of Health (DOH) standards and requirements for licensing primary care facilities in order to improve the delivery of quality health care to the patients and constituents;

WHEREAS, the Memorandum of Agreement (MOA) outlines the roles, responsibilities, and commitments of both parties to ensure an effective and sustainable health care service referral mechanism;

WHEREAS, an authority to sign the Memorandum of Agreement (MOA) has to be granted to the City Mayor by the Sanggunian concerned pursuant to the provision of Section 455 (b)(1)(vi) of the 1991 Local Government Code;

NOW, THEREFORE, on motion of Hon. Esther Marie B. Tongson, seconded unanimously by all Members present, it is;

RESOLVED, to grant authority to the City Mayor to sign the Memorandum of Agreement (MOA) to be executed by and between the Provincial Government of Negros Occidental and the City Government of Himamaylan relative to the establishment of partnership and referral system between the City Health Office and the Governor Valeriano M. Gatuslao Memorial Hospital;

RESOLVED FURTHERMORE, that a copy of the signed Memorandum of Agreement be furnished to this office;

RESOLVED FINALLY, to furnish copy of this resolution to all concerned for their information and appropriate action;

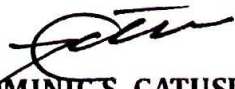
