ADOPTING LOCAL BUDGET CIRCULAR NO. 165 DATED JULY 18,2025 ISSUED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT RELATIVE TO THE IMPLEMENTATION OF THE SECOND TRANCHE OF THE UPDATED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNEL PURSUANT TO EXECUTIVE ORDER (EO) NO. 64, SERIES 2024 EFFECTIVE AUGUST 2, 2025 IMPLEMENTING ANNEX A-1 FOR PUBLIC HEALTH WORKERS AND ANNEX A-2 FOR NON-PUBLIC HEALTH WORKERS OF THE CITY

WHEREAS, Local Budget Circular No. 165, dated July 18, 2025, provides the implementation of the Second Tranche of the Updated Salary Schedule for Local Government Personnel Pursuant to Executive Order (EO) No. 64, Series 2024;

WHEREAS, Section 4 of the EO No. 64 stipulates that the updated Salary Schedule for civilian government personnel may likewise be granted to personnel of local government units (LGUs), subject to (a) authorization from the respective sanggunian as provided under Section 458(a) of Republic Act No. 7160 or the "Local Government Code of 1991," and (b) compliance with the Personnel Services (PS) limitation in the LGU budget under Section 325 of RA No. 7160;

WHEREAS, it is imperative for the local government to adopt and implement the provisions of Local Budget Circular No. 165 to ensure compliance with the prescribed salary adjustments and to support the welfare of local government personnel;

NOW, THEREFORE, on motion of Hon. Teresita A. Gamposilao, seconded unanimously by all Members present, it is;

RESOLVED, to adopt Local Budget Circular No. 165 Dated July 18,2025 Issued by the Department of Budget and Management Relative to the Implementation of the Second Tranche of the Updated Salary Schedule For Local Government Personnel pursuant to Executive Order (EO) No. 64, Series 2024 Effective August 2, 2025 Implementing Annex A-1 for Public Health Workers and Annex A-2 for Non-Public Health Workers of the City
