RESOLUTION

GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF HIMAMAYLAN RELATIVE TO THE COLLABORATION OF BOTH PARTIES TO ESTABLISH THE EMERGENCY 911

WHEREAS, Section 16 of the Republic Act 7160, otherwise known as the “ Local Government Code of 1991” provides that within their respective territorial jurisdiction, local government units shall ensure and promote health and safety, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Negros Occidental Emergency 911 was established in line with Presidential Executive Order No. 56, Series of 2018, wherein the public can seek assistance or report any emergency anywhere in the province by calling Emergency 911;

WHEREAS, the Memorandum of Agreement (MOA) outlines the roles, responsibilities, and commitments of both parties in enhancing emergency response capabilities and improving patient management;

WHEREAS, an authority to sign the Memorandum of Agreement (MOA) has to be granted to the City Mayor by the Sanggunian concerned pursuant to the provision of Section 455 (b)(1)(vi) of the 1991 Local Government Code;

NOW, THEREFORE, on the motion of Hon. Emmanuel V. Castro, seconded unanimously by all Members present, it is;

RESOLVED, to grant authority to the City Mayor to sign the Memorandum of Agreement (MOA) to be executed by and between the Provincial Government of Negros Occidental and the City Government of Himamaylan relative to the collaboration of both parties to establish the emergency 911;

RESOLVED FURTHERMORE, that a copy of the signed Memorandum of Agreement be furnished to this office;

RESOLVED FINALLY, to furnish a copy of this resolution to all concerned for their information and appropriate action
