APPROVING THE PROPOSED CONSTRUCTION OF LDRRMO SATELITE OFFICE IN BARANGAY TO-OY, HIMAMAYLAN CITY, NEGROS OCCIDENTAL FOR FUNDING BY THE OFFICE OF THE CIVIL DEFENSE-NEGROS ISLAND REGION (OCD-NIR) THROUGH ITS REGIONAL DIRECTOR DONATO SERMENO, III IN THE AMOUNT OF TWENTY-TWO MILLION PESOS (P22,000,000.00)

WHEREAS, the City Government of Himamaylan acknowledges the importance of strengthening disaster preparedness, response, and recovery mechanisms at the local level;

WHEREAS, the establishment of a Local Disaster Risk Reduction and Management Office (LDRRMO) Satellite Office in Barangay To-oy will serve as a vital facility for coordination, monitoring, and implementation of disaster risk reduction and management programs;

WHEREAS, the Office of the Civil Defense–Negros Island Region (OCD–NIR) has identified priority projects aimed at enhancing disaster resiliency and has made available funding support for such undertakings;

WHEREAS, Barangay To-oy has been identified as the most suitable site for the construction of a LDRRMO Satellite Office considering accessibility, land availability, and strategic location;

WHEREAS, the Office of the Civil Defense–Negros Island Region (OCD–NIR), through its Regional Director, Donato Sermenon, III, provides funding support for priority projects that promote innovation, sustainability, safety, and improved delivery of basic services;

WHEREAS, the city acknowledges the need for funding to carry out the planning, construction, and maintenance of the proposed LDRRMO Satellite Office;

NOW, THEREFORE, on the motion of Hon. Kerwin L. Tongson, seconded unanimously by all Members present, it is;

RESOLVED, to approve the proposed construction of LDRRMO Satellite Office in Barangay To-oy, Himamaylan City, Negros Occidental for funding by the Office of the Civil Defense–Negros Island Region (OCD–NIR) through its Regional Director Donato Sermenon, III, in the amount of Twenty-two Million Pesos (P22,000,000.00)
