APPROVING THE PROPOSED CONSTRUCTION OF REGIONAL EVACUATION CENTER IN BARANGAY LIBACAO, HIMAMAYLAN CITY, NEGROS OCCIDENTAL FOR FUNDING BY THE OFFICE OF THE CIVIL DEFENSE-NEGROS ISLAND REGION (OCD-NIR) THROUGH ITS REGIONAL DIRECTOR DONATO SERMENO, III IN THE AMOUNT OF SIXTY MILLION PESOS (P60,000,000.00)

WHEREAS, the City of Himamaylan recognizes the urgent need to establish a standard and well-equipped evacuation center to ensure the safety and welfare of its constituents during times of calamities and natural disasters;

WHEREAS, Barangay Libacao has been identified as the most suitable site for the construction of a Regional Evacuation Center considering accessibility, land availability, and strategic location;

WHEREAS, the Office of the Civil Defense-Negros Island Region (OCD-NIR), through its Regional Director, Donato Sermen, III, provides funding support for priority projects that promote innovation, sustainability, safety, and improved delivery of basic services;

WHEREAS, the city acknowledges the need for funding to carry out the planning, construction, and maintenance of the proposed regional evacuation center;

WHEREAS, the project will be of great benefit to those residing in the aforementioned areas;

NOW, THEREFORE, on the motion of Hon. Kerwin L. Tongson, seconded unanimously by all Members present, it is;

RESOLVED, to approve the proposed construction of Regional Evacuation Center in Barangay Libacao, Himamaylan City, Negros Occidental for funding by the Office of the Civil Defense-Negros Island Region (OCD-NIR) through its Regional Director Donato Sermen, III, in the amount of Sixty Million Pesos (P60,000,000.00)

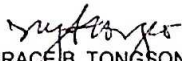
